Privacy commitment

Your privacy is important to us. We are committed to protecting your privacy and we want to ensure that you have a clear understanding about the information we collect about you, how we use it and who we share it with.

We provide a number of products and services that require us to collect, store, share and use personal information. This Privacy Policy applies when you use our products or services or interact with us or our website. It sets out how we collect information about you, how we use it and how we keep it secure.

What information do we collect?

Personal information is information about you that is reasonably identifiable (i.e. name, email address, contact details).

We may collect personal information that you voluntarily submit to us when you become a client, or which is provided to us by third parties.

The information we may collect (and hold) about you includes:

- tax file number;

- occupation, employment history and details;
- family commitments and social security eligibility;

- assets and liabilities (current and future), income, expenses;
- superannuation and insurance details;
- risk profile details and risk appetite;
- any other relevant information that you give to us for the purpose of providing you with our products or services.

Depending on the services we provide to you we may also collect sensitive information from you such as health information in connection with insurance application forms.

Why we collect, hold, use and disclose personal information

We will only use your personal information for the purposes for which it was collected (primary purpose) or for a purpose related to the primary purpose, if you would reasonably expect us to use the information for that purpose, or otherwise with your consent.

Our primary purposes for collecting, holding, using and sharing (disclosing) your personal information include but are not limited to:

- to protect our legal rights, interests and the interests of others, including in connection with legal claims, compliance, regulatory and audit functions and ensuring data security;
- to verify your identity pursuant to the Anti-Money Laundering and Counter-Terrorism Financing Act;
- to comply with our legal obligations, resolve any disputes that we may have with any of our customers, and enforce our agreements with other people;
- for any purpose related to the above.

Do we use your personal information for direct marketing?

Sharing (disclosing) your information

We share your personal information with:

- government agencies, regulatory bodies and law enforcement agencies, or as required, authorised or permitted by law including but not limited to the Australian

Taxation Officer (ATO), Australian Securities and Investment Commission (ASIC), the Australian Transaction Reports and Analysis Centre (AUSTRAC) and Australian Financial Complaints Authority (AFCA);

Information that we provide to other people will be handled in accordance with their privacy policy.

Mackay Private Partners Pty Ltd may also disclose your personal or sensitive information for other purposes if we notify you of the disclosure at or about the time of collecting the information, we have otherwise received your consent, or the disclosure is required or authorised by law.

Sharing (disclosing) your information outside Australia

In engaging our services, you acknowledge that we may share some of your information with organisations outside of Australia.

We store your data and information in the Cloud or other forms of networked storage for example, Microsoft OneDrive and Xplan. Due to the worldwide accessibility of such storage through the internet, it's not always possible for us to pinpoint the exact country where your data might be stored, accessed or retrieved.
